



FEES POLICY

1. PURPOSE

To ensure the NJNC Management Committee provide clear direction and provision of information to CLUB members in regards to member's fees.

2. SCOPE

This policy;

- applies to players involved with Sub Primary, Primary, Sub Junior, Junior, Inter and Senior teams; and
- does not apply to players named in State League or State League Reserves teams.

3. FEE STRUCTURE

- 3.1 The NJNC will employ a fee structure which complies with the CLUB Constitution and By Laws. An emphasis will be placed on minimising costs to members while ensuring that the costs of running the CLUB (e.g. equipment, insurances, Association fees, court & facilities hire, special projects etc) are able to be met.
- 3.2 The Management Committee shall set the fees payable by each age group for both winter & summer seasons at the first committee meeting held each year.
- 3.3 A trial fee will apply to all players wishing to trial for selection in teams for the winter season.
- 3.4 Family (i.e. two or more players of the same family residing at the same address) will be provided discounted fees at the following rates:
 - 3.4.1 The oldest player shall pay the full fee
 - 3.4.2 Second and subsequent players shall each be granted a 10% discount on the set fee for their age group.
- 3.5 Levies, determined necessary by the Management Committee may be introduced from time to time and will be included within the overall fee.

4. PAYMENT OF FEES

- 4.1 Information regarding fee amounts, how payment can be made and dates payments are due will be made available to players/guardians directly via the CLUB Secretary and also via the CLUB web site prior to winter selection trials.
- 4.2 Fees for winter competition selection trials are to be paid on or before the date set for the trials to take place.
- 4.3 Players accepting selection to play with NJNC during winter competitions must pay the full amount of fees applying to them on or before the date set by the CLUB for player registration day.
- 4.4 Fees payable for summer competition must be paid on or before the date set by the CLUB or prior to the player taking the court.
- 4.5 It is required that a player's fees are paid in full prior to the player taking the court.
- 4.6 NJNC provides the opportunity for fees to be paid by instalments. A written request seeking approval must be provided to the CLUB Secretary. The CLUB Management Committee will review each application before notifying the applicant of their decision.

4.7 Where arrangements have been sought from and agreed to by the Management Committee which differ to the conditions above, payment of fees must be made as agreed.

5. LATE OR NON PAYMENT OF FEES

5.1 If, unless otherwise agreed to with the Management Committee, full payment of a players fees has not been made by the 4th round of the season, or to pre arranged conditions, the player will not be allowed to participate in any further games until payment has been made.

5.2 A player who has outstanding fees at the end of a season will not be allowed to play in a following season until all outstanding fees have been paid in full.

6. REFUND OF FEES

6.1 In all cases (other 6.2.1), a fee refund will only occur after a written request (addressed to the CLUB Secretary) has been reviewed by and approved by the NJNC Management Committee.

6.2 A request to refund fees will only be considered subject to the following conditions:

6.2.1 a player having paid their trial fee but not being placed in any team, in which case the trial fee shall be refunded;

6.2.2 a player having paid their full fees, but subsequently is unable to play out a full season due to reasons deemed acceptable by the Management Committee (e.g. serious injury, ill health, unexpected relocation), in which case the Management Committee will consider a partial refund not exceeding 50% of the full fees; or

6.2.3 any unforeseeable reason arising in which NJNC may not be able to meet it's obligations to a player, in which case, after the matter being brought to the Management Committee's attention, the Committee will determine a fair and reasonable amount.

7. NON REFUND OF FEES

A request for a refund of fees will not be considered by the NJNC in the following situations:

7.1 a player choosing not to continue to play with the CLUB;

7.2 a player being unable to play/participate in games due to disciplinary reasons; or

7.3 a player or an associated member (e.g. family member) being expelled from the CLUB
