## CONDITIONS OF TRIALS

1. **All players to pay a non-refundable Trial Fee of \$50**
2. Selection is based on merit.  
**No player is guaranteed selection in any particular team.**
3. Players are expected to attend all trials. If you are unable to attend any trial you are expected to advise the Registration Officer by telephone 24 hours prior to the trial. In case of illness as soon as possible prior to trial start time.
4. **The number of teams selected is dependant upon the number of coaches and umpires available at the time of the trials.**
5. Where the selectors have difficulty in selecting a team or teams, the Club reserves the right to name a squad of two teams with players named in their respective teams before commencement of the season. In such instances, the players may inquire as to their probable placement before accepting a position in the squad.
6. Not withstanding the preceding, the Club also reserves the right to adjust teams during pre-season training or during the season if movement is warranted.

## TEAM / SQUAD ANNOUNCEMENTS

Player selections will be advised by **letter** within two weeks of completion of the trials.

Players must confirm their acceptance to the person named on their selection letter within the stipulated time.

**Failure to do so means your place will be offered to another player.**

## FEES - FAMILY DISCOUNTS AVAILABLE

A 10% deduction on fees for second player and subsequent players are available.
